TOWN BOARD MEETING  
May 6, 2009

**REGULAR MEETING:** The Town Board of the Town of Elbridge met in regular session on May 6<sup>th</sup> 2009 at 7:00 PM in the JE Community Center, Route 31, Jordan, New York.

Supervisor Bush called the meeting to order at 7 PM and Jordan Boy Scout Troop 57 led the Pledge of Allegiance.

**PRESENT:** Supervisor Ken Bush, Councilor George Betts, Councilor Bruce Ralston, Councilor Rita Dygert, and Councilor Vern Richardson.

**ADOPT MINUTES:** On a motion of Councilor Betts, seconded by Councilor Ralston to dispense with the reading of the minutes of April 15, 2009 and adopt minutes as written.

**MOTION TO PAY BILLS:** Councilor Richardson, seconded by Councilor Betts made a motion that General Bills Abstract #4, Vouchers # 221-269 in the amount of \$ 82,274.64 were ordered paid and Highway Bills, Abstract #4, Vouchers # 45H-60H in the amount of \$ 34,469.15 were also ordered paid for a total disbursement of \$116,743.79.

Maureen Doyle, as first guest, read several pages of a prepared letter regarding the Townwide reassessment, and gave several examples of properties, and how they vary. She believes the timing of this re-val also has an unfair disadvantage to taxpayers because real estate prices were inflated during the time properties were assessed.

The Supervisor asked for a copy of her written concerns, and she'll e-mail it.

Councilor Betts asked if all her examples were properties she felt were under assessed, and she confirmed this, and said she would also include, in her email, a list of other examples she feels are over- assessed. She thanked the Board for their time.

Historian: Jack mentioned the conference he attended recently in Albany, and copied many pages found of 1865 Civil War Veterans from the Town of Elbridge.

Senior Program Director: JET (J-E Transportation) will be what we call the 2009 wheelchair equipped, 12 passenger mini- bus. We'll be in the parade (May 25<sup>th</sup>), and also at Taste of Elbridge (June 24<sup>th</sup>).

Outreach Worker: Leo indicated in his report the luncheon for National Older Americans Month will be on May 19<sup>th</sup>, with entertainment by Loren Barrigar. Councilor Dygert ordered a banner for the new bus for the parade (to thank Senator DeFrancisco).

Recreation Director: Report on file. Great opening day at Seymour Lofft Park-parade and many games-good crowd, and beautiful weather.

Planning Board Chairman: Nothing at this time.

Supervisor Bush: quotes for fiber run between town buildings are in.
