

***APPLICATION FOR RESTRICTED BURNING PERMIT  
FOR THE TOWN OF ELBRIDGE***

**TOWN OF ELBRIDGE CONDITIONS**

1. Where local ordinances restrict open fires, the permit holder shall also obtain permission from local fire department or other local authority having jurisdiction.
2. Tire, fuel oil or similar materials, which cause visible emissions, shall not be used to ignite or sustain an open fire.
3. Tree trunks, stumps, and roots shall not be burned.
4. A restricted open fire is allowed only when prevailing winds are away from populated areas. Fires shall not be started during heavy winds.
5. The permit holder shall not conduct open burning during any stage of an air pollution episode or when a period of high fire danger is announced by the State Commissioner of Environmental Conservation.
6. The permit holder shall notify fire control prior to burning and shall show this permit to any person who requests to see it.
7. Rubbish piles to be ignited shall be isolated to prevent fire spreading.
8. No fire shall be unattended at any time or be left unattended until entirely extinguished.
9. The permit holder shall be liable for damage to tress or other property resulting from fires ignited by him.
10. Should it be necessary to extinguish any fire, the permit holder shall pay the entire cost of suppression.
11. This permit is non-transferable and may be suspended if the permit holder fails to comply with permit conditions.
12. Restricted burning shall not cause contravention of any applicable ambient air quality standard or cause air pollution.
13. This permit is valid only where the permit holder owns the site of open fire or where he has secured permission from the site owner. This permit authorizes no trespassing on private property.
14. Restricted burning **MUST** be supervised at all times.
15. No open burning to take place after dark.
16. The burn pile shall not exceed 100 square feet (10Ft x 10Ft) diameter maximum 4Ft high.
17. Trees/branches larger than a 4 inch diameter, plastics, rubber, vinyl, Styrofoam, paint, sludge, asphalt materials, chemicals, garbage, and the like are not to be burned.
18. No open burning to be permitted that will endanger any life or property.
- 19.** Materials to be burned must be generated and burned on the same site with any exception to be determined by Codes Enforcement Officer.
